Further to a discussion I had with you recently I write to seek the permission (in principle) of the Town Council for running outdoor fitness classes at The Heath, in accordance with the fitness groups policy and rules. I have recently become a franchisee of BMF with Bear Grylls and we are on a mission to get the UK active outdoors! BMF run professional, high quality, well organised outdoor fitness classes – more information can be found at www.bemilitaryfit.com. BMF also has a strong emphasis on community, creating and strengthening ties between members and holding regular social events that bring income to local venues.

My reason for writing is that I am in the process of developing a class timetable (partly dependent on venue), arranging insurance etc, so cannot fully complete an 'Open Space Group User' form at this time. However, I must propose a venue to my franchisor for approval and cannot do so without being sure it can be used in the intended way. At present I am able to provide the following outline information:

- A typical timetable would be classes at 0700, 0930, 1900 or similar times, initially anticipated on 3 days per week, increasing dependent on demand.
- Activities include bodyweight and minimal equipment workouts (e.g. marker cones, resistance bands, kettlebells).
- Music is not used during classes.
- A meeting point will be designated and listed on the BMF website, with any instructions that members need to adhere to if necessary (e.g. avoid use of a particular location for parking).
- My planned launch date is TBC, anticipated end of October/beginning of November. Ideally there would be some taster sessions in the 3-4 weeks leading up to this.
- BMF operate a strict social distancing and hygiene protocol named BMF-20 at all venues to guard against the spread of COVID-19.
- All risk assessments, insurances etc. will be in place at the time of launch.

If approval in principle is granted and the venue is submitted to and approved by my franchisor, I would complete a group user form as soon as practicably possible. If necessary I would be happy to further discuss arrangements with the Town Council to ensure the environment of The Heath is protected, users are not unnecessarily disturbed and conflicts with other activities are avoided, but in the meantime I hope this information is helpful. Now more than ever it is so

important that our communities are as active and healthy as possible, and I sincerely hope that I can work with you to encourage this in Petersfield.

I would like to be able to submit my venue as soon as possible for approval, as it would be helpful to get classes underway before winter sets in. Thank you for your response. This is understandably disappointing, although I appreciate the reason. It is important to manage the pressures placed on outdoor spaces such as the Heath to preserve their special qualities.

I would just say that as a former landscape architect and manager I feel well placed to ensure any impacts are minimised compared to other fitness instructors. Sustainability is an important part of the BMF approach and I would normally expect to be paying a fee for the licencing/upkeep of any site used for classes. Regarding coronavirus, BMF wrote the guidance provided to UK Active for outdoor activities which is embodied in the BMF-20 protocol, so are well placed when it comes to operating safely and responsibly in these challenging times.

When you say you will come back with more information, is this regarding where the Town Council and Grounds Committee would consider the most suitable alternative site within Petersfield, or more to do with policy moving forward for all enquirers? Do you have an anticipated timescale for this? Winter is on the way and I need to find a site, either in Petersfield or elsewhere, as soon as possible.

Thank you for the attached.

By way of clarification, PTC did apply for change of use for the entire Penns Field site back in early 2019. Recreational & sports use was approved for the current sports pitch area and recreational use was approved for Field B – despite the fact that it is the same planning classification.

I also seem to recall that the rugby club had said in the past that if rugby pitches were placed in Field B and the hedge left in-situ then they would not be usable because of the risks involved from a child protection perspective. Would that still be the case or has this assessment changed please?

The Council has no difficulty with the club pursuing the planning application for floodlighting as suggested.

Dear Members of the PTC Grounds Committee,

I hope you don't mind me sending a blanket e-mail, but following my presentation at your recent meeting, there have been some developments around our Penns B planning application. I wanted to make you aware of.

Please see below the e-mail chain below, correspondence between Nicky Powis (EHDC Planning Officer) and myself on the Penns B matter

Please find attached the official rejection Notice with respect to our Application for Penns B.

From my presentation, we were expecting the Rejection and I have provided new plans for the area – PRFC Sports Pitch Positioning – 4 (attached), leaving the hedge (which ahs caused so much debate) untouched apart from ongoing maintenance.

We now need to progress this new design with the Planners for which I see two issues to address:

1. By Petersfield RFC.

- 1.1 Complete pre-application paperwork for the relocation of Pitch 4 and installation of floodlights. Whilst I am awaiting confirmation details for the design, my thoughts from information previously submitted are that we will be able to demonstrate that the floodlights will not spill light into the SINC or the hedge and conform the SDNP Dark Skies E0 Policy.
 - We will also install timers to ensure the lights shut off at 9.30pm in line with their previous requirement the environmental officer had no issues with this arrangement previously
 - I personally cannot see what issues they can raise the pitch exists currently, there will be no light spillage, no animals are affected
- 1.2 We will have the pre-application meeting
- 1.3 We will provide a Planning Application based on our discussions in 1.2

2. By PTC - Change of Use of the Penns B Area

- 2.1 The existing Penns Field are currently listed as agricultural although sport has been played on them for 30 years+
- 2.2 My understanding is that the change of use application by PTC previously was turned down due to a technicality of not providing enough information in respect to Penns B as part of the overall Penns Field application.
- 2.3 If we are to install 2 rugby pitches in Penns B (not touching the hedge which we want to) then PTC need to apply for change of use.
 - My understanding is that The Change of Use needs to be a Planning Application, such that there is a time limit on a response from the Planners as previously they sat on it for months.
 - This needs to be checked and the Club will be very willing to help put this information together with you

In leaving the hedge in situ and undertaking the new scheme – the costs of overall works is greatly reduced as we will not have to remove hedgerow and move earth etc. – but simply plough up Penns B and process to flat pitches, stone pick and install land drainage and plant grass

With a large farming community as Rugby Club members and one of them providing grass seed to us annually – together with self-help labour from the club this could be undertaken quickly to further reduce costs.

Part of me also cannot see how the planners can dictate what you as the owner do in the field Currently it is used by dog walkers – that will continue

The animal life in the field itself is minimal (3 slow works seen in 2 years – we have the Ecological Report)
The benefits to the Community in team sport (exercise, mental health help etc.), particularly during and post COVID fall in line with what the Government wants and the scheme falls in line with the Neighbourhood Plan for a Sports Hub for this particular area.

Can I please request that you consider the above and come back to me.


I intend to submit the pre-application paperwork early next week and get the ball rolling with respect to floodlights – unless you have an issue with that.

Teddies to meet Santa

Venue: Petersfield Heath

Date: Saturday 5th December 2020.

Start: 3.45pm

The heath play area should be quiet as it will be dark at this time of the year.

The event is planned to have 3 areas of activity, this will mean that social distancing can be practiced with ease.

There will be at least 2 members of the Save the Children (STC) committee to steward each area. This will ensure that people stay in their family bubble of no more than 6 at all times and maintain the 2 metre distance.

Area 1

This is by the children's slide. A table will be positioned where an STC member will sit. Teddy Bears will be placed on the end of the table where the steward will place a clip on the bear and put it in a basket which will have a plastic bag inside.

When the whole of the family has deposited their bears the basket will be taken to the slide where another steward will take it to the top of the slide and clip the bear onto the zip wire.

Once all of the basket are down the bears will be placed back into the plastic bag and taken to the collection point, which will be away from the table. The owners collect the bears and then move on. I envisage the event moving round the Heath in a one way system. All Stewards will sanitise their hands before and after touching the bears. The plastic bag will be replaced after each family group.

Area 2

Near The Plump Duck. A gazebo with 2 tables will be selling Christmas decorations etc. The tables will form a V shape and people will only be able to walk along from left to right and one family at a time. Again stewards (STC) will ensure that distancing rules are observed.

Area 3

Across the bridge of the lake. Families will be lead across the bridge, which will be lit with fairy lights, to a Santa Grotto at the far end. Groups will be led by a steward with a torch. At the Grotto the group can stand and see Father Christmas and his elves, there will be a basket with a gift for each child. The steward will place the gift onto a small table for collection. The group will leave the grotto by walking along the path by the road, thus maintain the one way system.

In addition, if approval is given, I would like to ask the Salvation Army band to play some carols and ask The Plump Duck to stay open as I would not want it to miss out on the extra custom.

How Tree Wardens Tree Wardens Can make a difference in your fown or parish The East Hants Tree Warden Network was one of the first to be formed in Britain when the Tree Warden Scheme was launched by the Tree Council as a national initiative in 1990.

Tree wardens are volunteers appointed by their Parish and Town Council to:

- be contacts and support for all things tree related in their local areas
- protect trees by reporting early signs of pests, diseases and vandalism
- gather information, survey and record information about trees important for amenity, wildlife or heritage in their parish
