Sophie,

Here is the wording...

The recommendation from PHC reads:

To undertake a full refurbishment of the Festival Hall, under option 5 of the FHWP's September 2020 report to explore the cost and possibility of bringing the Festival Hall offices into community use under the scheme.

On reflection, this sounds like the decision, if adopted by the full council, would be irreversible and unnecessarily risky at this point in time. As such, I propose the following amendments/safeguards:

- 1. That Foster Wilson are instructed for RIBA3 that the final plan should be arranged in such a way that each zone could be undertaken as a specific project. Thus, if after RIBA3 and public consultation, if the council would only want to undertake is zone 1, then we would have an 'oven ready' RIBA 3 project to go ahead with for a much more limited RIBA 4/5.
- 2. That no increase in precept would be recommended for FH work (excluding the £217k already in the annual budget) until after the result of grant applications post RIBA3.
- 3. That at the point of the RIBA3 public consultation, a period of time post-COVID and significant grant applications, the Public Halls Committee need to reevaluate the decision to go for the full refurbishment with recommendation to proceed made to full council or a recommendation for another option.
- 4. That Foster Willson are instructed for RIBA3 to make further improvements to account for a much more carbon neutral building, achieving the highest standards possible and affordable (Cllr Palmer to advise specifics)

Please let me know if you think of anything else or how I can reword to ensure these safeguards 'have teeth' while at the same time moving the project forward in terms of planning and finance scenario planning.
